## Cancellations and Refund Policy

There will be no refunds for scratched tests after the entry closing date.

Entry Cancellation: We encourage participants to get their show entries in early. Entries sent with check payment will be received and held, not processed until 90 days prior to the event. Received entries on hold may be cancelled. CDNW will destroy the check and not process upon request.

Entries on hold or received after 90 days prior to event will be processed in a timely fashion. As entry is processed, checks will be cashed.

CDNW encourages these options to cancellation in the event the horse is unable to perform as planned:

- Classes entered may be revised up to the day before.
- Horse entered may be changed up to the day before.

Partial refund may be granted as follows:

Any request for cancellation or refund shall be submitted in writing, preferably email. Please include a veterinarian's statement if applicable. [cdressagenorthwest@gmail.com](mailto:cdressagenorthwest@gmail.com)

- Request for refund will be reviewed and approved after the event by a third party.
- Timing will play a part in approval of many fees as filling vacated entries will be considered in the refund review.

Any approved refunds will be processed within 30 days after the event.

- Once entry has been processed, there will be no refund of office fees, late entry fees or Cowboy Dressage World non-member fees.
- Class entry fees will not be eligible for refund unless there is a valid medical / veterinary condition, and/or the vacated class spot can be filled.
- Clinic participants will not be eligible for refund unless the vacated spot in the clinic can be filled.
- Clinic Audit or Fun Class fees may be refunded if participant is not on show grounds.
- Stall fees or Haul in fees may be refunded if horse is not on show grounds.
- Camping fees may be refunded if not used.
